



2018 Annual Member Meeting Prize Giveaway Official Rules

1. **No purchase is necessary.**
2. **ELIGIBILITY OF PROMOTION.** All members of Coca-Cola Federal Credit Union (**Credit Union**), address being 1 Coca-Cola Plaza, NW Atlanta, GA 30313, attending the Annual Meeting via webcast on Thursday, May 17, 2018 are eligible for the prize drawings. Individual registration for webcast is required to participate in the contest. Members must be 18 years old or older and accounts must be in good standing to qualify for entry in the prize drawings. Visit creditunion.coca-cola.com from April 1 – May 17, 2018 to obtain sign-on information for the Annual Meeting webcast. Employees, Board Members, and Committee Members of the Credit Union and their immediate family members residing in a single household are not eligible.
3. **PRIZES.** The Credit Union will award five (5) gift cards as prizes (non-redeemable for cash) via random drawings as follows: 1st prize-\$500.00 gift card, 2nd prize-\$400.00 gift card, 3rd prize-\$300.00 gift card, 4th prize-\$200.00 gift card, and 5th prize-\$100.00 gift card. **Odds.** The odds of winning depend on the number of eligible registered webcast attendees. Some restrictions apply. No substitution of prize permitted.
4. **Entry and eligibility** for this prize promotion is based upon: one registration for the webcast per eligible member who signs on to the webcast with first and last name and has a verifiable membership in good standing with the Credit Union. Entry will be based on the first party named on the account regardless to whether the account is a multiple party account; and regardless to whether the information for this promotion is actually provided and submitted by the first party named on the account. The names will be selected from the webinar list of registered entrants and winners will be announced during the webinar. The gift cards will be forwarded to the winners' address of record within three (3) business days after a signed prize acceptance form is received by the Credit Union. The prize will be automatically forfeited if a signed prize acceptance form is not received within two (2) business days after form is sent to winners and another name will be selected. Prize acceptance forms should be sent to cucommunications@coca-cola.com. The prize will be awarded only if entrants comply with these Official Rules.
