1. **No purchase is necessary.**

3. **PRIZES.** The Credit Union will award one (1) Apple Watch as the raffle prize. Prize valued at \$155.00. **Odds.** The odds of winning depend on the number of eligible entry forms received. Some restrictions apply. No substitution of prize permitted.
4. **Entry and Eligibility:** The winner will be the one with the most accurate guess of plain M&Ms in the Coke Contour bottle on display at the lobby day event. If there is a sole winner, he or she will be notified by COB Wednesday June 27, 2018.
