2018 Lobby Day Prize Drawing Official Rules

3. **PRIZES.** The Credit Union will award three (3) Treat Your Feet Gift Cards as the raffle prize. Prize valued at \$50.00. **Odds.** The odds of winning depend on the number of eligible entry forms received. Some restrictions may apply. No substitution of prize permitted.
