Prize Drawing Official Rules

1. **No purchase is necessary.**
2. **ELIGIBILITY OF PROMOTION.** Credit Union membership is not required. Anyone age 18 years or older attending the Credit Union Lobby Day on Thursday, October 18, 2018 is eligible for the prize drawing. Only one entry is permitted per person. Employees, Board Members, and Committee Members of the Credit Union and their immediate family members residing in a single household are not eligible.
3. **PRIZES.** The Credit Union will award three (3) gift cards as raffle prizes. Prizes valued at \$25.00 each. **Odds.** The odds of winning depend on the number of eligible entry forms received. Some restrictions may apply. No substitution of prize permitted.

Prize winners are responsible for all federal, state, local or other taxes or other assessments that may be associated with or imposed upon the winner of any prize in this promotion.

4. **Entry and eligibility** for this prize promotion is based upon: one entry submitted per eligible attendee who attends. Entry consists of completing the entry form based on one name per person; and regardless of whether the information for this promotion is actually provided and submitted by the first party named on the account. No cell phone use is permitted to obtain trivia answers. The winners will be selected within 48 hours after the lobby day and the winner will be notified by phone or email. Arrangements will be made with the winners for the pick-up or delivery of the prize, including completion of a prize winner release form if required.
