



# 2024 ANNUAL MEMBER MEETING PRIZE GIVEAWAY OFFICIAL RULES

1. No purchase is necessary.
2. **ELIGIBILITY OF PROMOTION:** All members of Coca-Cola Federal Credit Union (Credit Union), address being 1 Coca-Cola Plaza, NW Atlanta, GA 30313, attending the Annual Meeting via webcast on Thursday, May 23, 2024 are eligible for the prize drawings. Individual registration for webcast is required to participate in the contest. Members must be 18 years old or older and accounts must be in good standing to qualify for entry in the prize drawings. Visit our web-site at [creditunion.coca-cola.com](http://creditunion.coca-cola.com) from May 1 – May 23, 2024 to obtain sign-on information for the Annual Meeting webcast. Employees, Board Members, and Committee Members of the Credit Union and their immediate family members residing in a single household are not eligible.
3. **PRIZES:** The Credit Union will award five (5) prizes via random drawings as follows: 1st prize (1) \$500.00, 2nd prize (1) \$400.00, 3rd prize (1) \$300.00, 4th prize (1) \$200.00, and 5th prize (1) \$100.00. Odds. The odds of winning depend on the number of eligible registered webcast attendees. Some restrictions apply. No substitution of prize permitted.

Entry and eligibility for this prize promotion is based upon: one registration for the webcast per eligible member who signs on to the webcast with first and last name and has a verifiable membership in good standing with the Credit Union. Entry will be based on the first party named on the account regardless of whether the account is a multiple party account; and regardless to whether the information for this promotion is actually provided and submitted by the first party named on the account. The names will be selected from the webinar list of registered entrants and winners will be announced during the webinar. The prize money will be deposited into the savings account of the winners within three (3) business days after a signed prize acceptance form is received by the Credit Union. The prize will be automatically forfeited if a signed prize acceptance form is not received within two business (2) days after form is sent to winners, after which another name will be selected.
